Sealed bids for the **County Road 4 Waterline Relocation CMOB190117(1)** will be received at Utilities Board of the City of Gulf Shores (Gulf Shores Utilities) office located at 1629 E. 1<sup>st</sup> Street, Gulf Shores, AL 36542, until **Thursday, August 12, 2021 at 10:00 a.m.** local time at which time the Bids received will be publicly opened and read in the Board Conference Room.

The Project includes the following Work: **This project consists of relocation of existing water and wastewater utilities to accommodate a future road to be constructed in a separate project by ALDOT. Specifically this project consists of installing 240 LF of new 16 inch diameter PVC C-900 waterline and 450 LF of new 6 inch PVC C-200 sanitary sewer line along with all necessary clearing, related bends, thrust block appurtenances and encasement pipe as per the bid plan set. Twenty-One (21) calendar days are allotted for this project.**

Bidding Documents also may be examined at the Office of Gulf Shores Utilities, Gulf Shores, AL between the hours of 8:00 a.m. – 4:30 p.m. CST, Monday- Friday.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of \$20.00 for a one time administrative fee for digital access/file sharing and/or \$75.00 for each set. Said cost represents the cost of printing, reproduction, handling, and distribution, therefore no refund will be granted. Checks for Bidding Documents shall be payable to "GMC." Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bid security shall be furnished in accordance with the Instructions to Bidders.

The Owner reserves the right to waive any informalities, or to reject any or all bids, and to award the contract to the best and most responsible bidder. All bidders shall submit, upon request, a list of projects "successfully completed" in the last 2 years, having the same scope of work and approximate construction cost as specified in this project. All bidders must comply with requirements of the Contractor's Licensing Law of the State of Alabama and be certified for the type of work on which the proposal is submitted. Each bidder must deposit with his bid, security in the amount, form and subject to the conditions provided in the Instructions to Bidders.

All Bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or bid will not be received or considered by the Engineer; the Bidder shall show such evidence by clearly displaying the license number on the outside of the envelope in which the Proposal is delivered.

No bidder may withdraw his bid within 60 days after the opening thereof.
