Sealed Bids for the construction of the **Walhalla Greenway, CGRE210033** will be received, by the **City of Walhalla**, at their offices located at 206 North Church Street, Walhalla, SC 29691, until **2:00 pm** local time on **Thursday December 8<sup>th</sup>, 2022, 2022** at which time the Bids received will be **publicly** opened and read. The Project consists of **the installation of approximately 4,500 LF of concrete greenway, demolition, earthwork, storm drain installation, striping, landscaping, and other miscellaneous work to incorporate the new greenway into the existing landscape.**

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis.

Bid security shall be furnished in accordance with the Instructions to Bidders.

**This project is being funded in whole or in part by the Appalachian Regional Commission (ARC). All federal ARC requirements will apply to the contract. All contractors and subcontractors are required to be registered in the federal System for Award Management (SAM). Bidders on this work will be required to comply with the President’s Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, the Contract Work Hours and Safety Standards Act, and 40 CFR 33.240.**

Bidders must also make positive efforts to use small and minority-owned business and to offer employment, training and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract.
