The Work of the project includes, but is not limited to, construction of sidewalks, plant edging, flag poles and landscaping on 0.1 acre site and all related work, as indicated in the Bid and Contract Documents.

A cashier's check or bid bond payable to USS ALABAMA BATTLESHIP COMMISSION in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal. Performance and statutory Labor and Material Payment Bonds, insurance in compliance with requirements, and verification of E-Verify enrollment (also with Proposals), will be required at the signing of the Contract.

Bid Documents may be obtained from the Architect upon payment of a deposit of **Twenty dollars (\$20.00)** for a one-time administrative fee for digital/file sharing access or **Seventy-Five dollars (\$75.00)** (printed) per set. Contractors are encouraged to use the digital plans. Refunds will be issued for printed sets only issued by the **Architect** to each **general contract bidder** on the first two (2) sets issued submitting a bonafide bid, upon return of documents in good and reusable condition within ten (10) days of bid date. Other sets for general contractors, and sets for subcontractors and dealers, may be obtained with the same deposit, which will be refunded as above, less cost of printing, reproduction, handling and distribution, which is estimated to be the same as the deposit amount.

Bids must be submitted on proposal forms furnished by the Architect or copies thereof. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the Provision of Title 34, Chapter 8, Code of Alabama, 1975, as amended, and must show such evidence of license before bidding or bid will not be received or considered by Engineer or Owner; The bidder shall show such evidence by clearly displaying their current license number on the outside of the sealed envelope in which the proposal is delivered; Bidder must also include their current license number on the Proposal Form. The Owner reserves the right to reject any or all proposals and to waive technical errors if, in the Owner's judgment, the best interests of the Owner will thereby be promoted. No bid may be withdrawn after the scheduled closing time for receipt of bids for a period of SIXTY (60) days.

**A NON-MANDATORY PRE-BID CONFERENCE** will be held at the USS Alabama Battleship Memorial Park, Commission Room located at **2307 Battleship Pkwy, Mobile, AL**; at **10:00 AM LOCAL TIME ON THURSDAY**,

**NOVEMBER 30, 2023**, for the purpose of reviewing the project and answering Bidder's questions. Attendance at the Pre-Bid Conference is encouraged but not required.

This project is being bid **EXCLUDING TAXES**, and requires the Contractor comply with the requirements of Act 2013-205, which was signed into law on May 9, 2013. The Contractor and the Owner will be required to apply for Certificates of Exemption with the Alabama Department of Revenue which will handle administration of the Certificates. The Contractor shall account for the tax savings on the Proposal Form.

Additional qualifications and requirements for General Contractor Bidders and separate Subcontractors and Manufacturers are indicated in the Bid and Contract Documents.
