"A contractor must have a Heavy and Railroad major license or a Heavy and Railroad specialty license to **bid as prime for this project.**"

Bids may be held by the Prattville Airport Authority for a period not to exceed ninety (90) days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.
