The Work of the project includes, but is not limited to, selective demolition and reroofing at the Tallapoosa County CourtHouse; coordination and supervision of the entire project, and all related work, as indicated in the Bid and Contract Documents.

A cashier's check or bid bond payable to TALLAPOOSA COUNTY COMMISSION in an amount not less than five (5) percent of the amount of the bid, but in no event more than \$10,000, must accompany the bidder's proposal. Performance and statutory Labor and material Payment Bonds, and insurance in compliance with requirements, will be required at the signing of the Contract.

Drawings and Specifications may be examined at the Office of the Architect; and digital Plan Rooms of: Dodge SCAN and Construct Connect Internet Plan Room.

Bid Documents may be obtained from the Architect in PDF format for a one time deposit of \$25.00 (non-refundable), and/or upon deposit of \$75.00 per set, which will be refunded in full on the first two (2) sets issued to each general contract bidder submitting a bonafide bid, upon return of documents in good and reusable condition within ten (10) days of bid date. Other sets for general contractors, and sets for subs and dealers, may be obtained with the same deposit, which will be refunded as above, less cost of printing, reproduction, handling and distribution, which is estimated to be the same as the deposit amount. *Partial sets will not be available.*

Bids must be submitted on proposal forms furnished by the Architect or copies thereof. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the Provision of Title 34, Chapter 8, Code of Alabama, 1975, as amended, and must show such evidence of license before bidding or bid will not be received or considered by Architect or Owner; The bidder shall show such evidence by clearly displaying their current license number on the outside of the sealed envelope in which the proposal is delivered; Bidder must also include their current license number on the Proposal Form. No bid may be withdrawn after the scheduled closing time for receipt of bids for a period of SIXTY (60) days.

A PRE-BID CONFERENCE will be held at the same location where bids are to be opened at **10:00 AM LOCAL TIME ON TUESDAY, NOVEMBER 19, 2024**, for the purpose of reviewing the project and answering Bidder's questions. Attendance at the Pre-Bid Conference is recommended for all General Contractor Bidders intending to submit a Proposal, and is highly recommended for all Subcontractors.
