Major items of work include: Pavement Removal, Grading, Drainage, Base, Pave (Asphalt & Concrete), Surface Treatment, Markings and Aircraft Tie-Downs for the GA Apron Reconstruction. Concrete Spall and Joint Repair for the Terminal Apron Rehabilitation.

All Bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, and must show evidence of license before bidding or bid will not be received or considered by the Engineer; the Bidder shall show such evidence by clearly displaying the license number on the outside of the envelope in which the Proposal is delivered. "A contractor must have a Heavy and Railroad major license or a Heavy and Railroad specialty license to **bid as prime for this project**."

Bids may be held by the City of Cullman / Cullman County for a period not to exceed ninety (90) days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.
